- John Glaubitz(Vertex) led the group in discussions for the Retail Industry Ontology (RIO) regarding Price, Amount, rounding values in promotions, Loyalty Rewards, Tender Types, and how to handle specialization for different retail industry verticals
- Richard Halter presented an incredible catalog of free educational content describing and teaching the ARTS Data Model, POSLogand other retail technology assets.
- Made progress on deciding what is needed for Micro-Location in Retail. There is more to
 investigate regarding how a new release would look. We know why something new is
 needed, but the particular form it should take is still to be determined.
